MOTION: Hopp/Bonner to have Clerk Perkins prebuy propane from Gary Oil in the amount of \$1650.54 (there is \$4,642.94 left on prebuy from last year). 3) Supervisor Griffith stated that he has talked with Township Assessor Tammy

Fall and that she is no longer interested in being the assessor for Curtis Township, she advised Supervisor Griffith that the county knows of someone that may be interested in being our assessor. Supervisor Griffith has already been in contact with Troy Somers, Alcona County Equalization Dept

CORRESPONDENCE: Clerk Perkins received a letter regarding the gypsy moth problem and what can be done about it. This problem is being looked at.
